2026 Ozaukee County Executive Committee's Recommended Budget

County Administrator Jason Dzwinel

Mr. Dzwinel presented the 2026 Proposed Budget, as recommended by the Executive Committee, which included Budget Themes – Staff, Stability, Surplus, Sales Tax, Revenues, Expenditures, Tax Levy, Net New Construction, and 2026 Budget Summary.

Questions were addressed following the presentation.

County Board Chairperson Schlenvogt recommended the reappointment of Kristen Berns and Theresa Couwenhoven as members of the Aging & Disability and Resource Center. Motion by Supervisor Kincaide, seconded by Supervisor Nelson to reappointments. Voice vote, motion carried.

There were no committee reports.

Under supervisor announcements, Supervisor Hansher addressed the October 16th Jail Literacy Program Fundraiser. Supervisor Kincaide announced the City of Cedarburg will participate in Operation Greenlight by illuminating a green light on Veteran's Day and that a presentation on the situation of homelessness in Ozaukee County will be held at the Non-Profit Center in Grafton on October 23rd.

Motion made by Supervisor Nelson, seconded by Supervisor Jobs, to adjourn, subject to call by the Chairperson, or until Monday, November 3, 2025 at 7:00 PM to conduct the public hearing on the Proposed 2026 Budget.
